



Lori's Dance Covid-19 Policies Fall 2020

Arrival Procedures:

1. **Be on time!** Punctuality is crucial in order to properly enforce our safety procedures.
2. Face coverings are required in our lobby.
3. Dancers must arrive in dance clothing. There will be no changing in the studio.
4. Dancers will be temperature scanned and asked to sanitize their hands before entering the classroom.
5. Dancers will place their masks, street shoes & belongings in an individual plastic container in the lobby.
6. Dancers will be escorted to a personal 6 x 6 space. Water bottles are the only personal items allowed in the classroom.

Class procedures:

1. All students will dance in 6 x 6 squares to ensure physical distancing.
 - a. Studio A can fit fifteen 6 x 6 squares. Therefore, classes in studio A will not exceed 15 dancers.
 - b. Studio B can fit ten 6 x 6 squares. Therefore, classes in studio B will not exceed 10 dancers.
2. Teachers will wear a face covering at all times when they cannot maintain 6 feet from dancers.
3. Dancers are not required to wear face coverings in the studio room, but are welcome to do so.
4. Ballet barres will be sanitized between each use.
5. Acro students will be provided with a small personal mat that will be properly sanitized after each use.
6. The use of cubbies will not be permitted at this time until further notice.
7. The bathroom will be designated for one person per use. The bathroom will be sanitized frequently.
8. A designated staff member will be tasked with enforcing social distancing as well as frequent cleaning of all high-contact surfaces throughout our hours of operation.

Dismissal procedures:

1. Parents/Guardians should arrive to the LDC parking lot in a designated parking spot 5 minutes prior to the end of class for pick up. **DO NOT FORM A LINE IN THE PARKING LOT IN FRONT OF THE STUDIO.**
2. The lost and found has been removed.
3. Dancers may only be in the studio when they are attending their registered class. Only dancers taking two consecutive classes may remain in studio during the 10 min cleaning period. All other dancers must leave the studio at the conclusion of their class. This means if your dancer has an hour break between classes, they must be picked up by a parent/guardian and return at the time of their next class.

Cleaning/Safety Procedures:

1. LDC has installed the REME Halo air purification mechanism in our HVAC system. The award winning REME HALO® whole home in-duct air purifier is the next generation of indoor air quality (IAQ) technology and capable of purifying every cubic inch of air that your central air conditioning system reaches. Designed to eliminate sick building syndrome risks by reducing odors and air pollutants, the REME HALO® whole home in-duct air purifier is the best solution for whole house and building air purification.
2. The entire studio will be sanitized nightly by staff, and a deep cleaning will take place once a week by a professional company.
3. There will be 10 minutes between each class for staff to sanitize all high-contact surfaces and the restroom.
4. There will be a designated staff member tasked with monitoring the safety and cleaning procedures during hours of operation.
5. Students will be mandated to keep their cellphones with their personal belongings inside of the designated plastic container in the lobby. Parents/Guardians may call us at (631) 581-0024 if they need to contact their dancer.

Exposure Procedures:

1. In the event that an LDC dancer or family member contracts Covid-19, we will refer to the guidelines put forth by our local officials.
2. Dancers who test positive for Covid-19 must remain home until they have been cleared by a doctor and **must provide documentation.**
